

CITY OF PALOUSE RV PARK FOURTEEN DAY PREPAY AGREEMENT

The CITY OF PALOUSE RV PARK agrees to rent to the GUEST, Site # _____; GUEST anticipates being in the park from _____ to _____ (14 day maximum prepaid). If the GUEST elects to extend their stay (7 days maximum), it is the sole responsibility of GUEST to notify the City Hall Office in writing as the site may have new reservations after said ending date. If new reservations exist and the park was not notified, the GUEST will be required to move to another site.

The Rental Term shall be on a day-to-day basis, which may be terminated at any time by the CITY OF PALOUSE RV PARK.

The Guest agrees to pay the CITY OF PALOUSE RV PARK the full amount of \$ _____ in advance. Payment for an extended stay must be paid in full at the end of the initial prepaid stay.

The GUEST understands that the above mentioned is based on 1-2 adults and 2 pets per site at **\$25.00 Per Day**. Additional site guests will result in an increase per day of **\$2 per additional adult**. Limits: 4 adults and 2 pets per site. The GUEST agrees to keep pets on a leash at all times. Pets cannot be left on leash tied to Unit unless GUEST IS at the site and can maintain quiet with pet. Pet waste bags are available at the City Park.

The GUEST understands that the rental amount is subject to increase. CITY OF PALOUSE RV PARK agrees to supply GUEST with **written notification of any increases in the rate 15 days prior to GUESTS' next payment** due.

This property is a public facility, the GUEST accepts camping privileges with the understanding that he/she does hereby release the CITY OF PALOUSE RV PARK, its owners, officers and employees of any liability for loss or damage to property and injury to his/her-self while using the camping facilities and agrees to indemnify CITY OF PALOUSE RV PARK, its owners, officers and employees against claims resulting from loss or damage to property or injury to the person or any member of the family or guest of the GUEST, arising out of the use of its camping facilities.

The GUEST agrees to read and comply with all CITY OF PALOUSE RV PARK Rules and Regulations as provided in the City Hall Office and at the facility information kiosk. **It is the GUEST'S responsibility** to secure a listing of all Rules and Regulations.

GUEST agrees to carry his/her own liability and comprehensive insurance and vehicle registration during the term of this Agreement. GUEST will furnish proof of insurance to the CITY OF PALOUSE staff if requested.

GUEST understands that outside storage is strictly prohibited, as is the erection and use of any permanent or semi-permanent structure, decking, enclosure or fence. Site must only have lawn chairs, portable fire pit, free standing barbecue and picnic table. Nothing may be stored under or around the RV. Ground mats must stay on gaveled areas only.

GUEST acknowledges that the CITY OF PALOUSE RV PARK is hereby given a lien upon the property described above to secure all site rental fees, repairs, hardware, materials, labor or services rendered to or supplied to GUEST during the terms of this Agreement. Any item left in leased site 15 days beyond the expiration of this Agreement shall be surrendered to the Palouse Police Department and offered for public sale to cover site rental charges.

The GUEST understands all RV's must be in good condition, clean and well maintained. If not, GUEST may be asked to vacate CITY OF PALOUSE RV PARK.
